The Regional Innovation Center of EIT RawMaterials (RIC) is a public legal entity subordinate to the Ministry of Infrastructure and Energy, based in Elbasan, established by Decision of the Council of Ministers no. 697, dated 6.12.2023. Its mission is to coordinate activities related to innovation and development in the raw materials sector, in cooperation with EIT RawMaterials, supporting the effective management and processing of mineral raw materials at the national and regional level. The center fosters innovation, strengthens the extractive and processing industry, introduces green technologies, provides training and entrepreneurial mindset for higher and vocational education, and helps prepare a qualified staff by limiting the departure of young people.
